# **Job Summary:**

Monitors, directs, and implements the financial activities of the Broward County Housing Authority and affiliated organizations. Ensures maximum utilization of program funds utilizing effective budgetary controls and financial analysis. Performs a variety of administrative and supervisory tasks involving maintaining financial records and preparing reports for internal use; reviewing and approving general ledger entries; preparing and analyzing the low-income housing tax credit properties, operating budget, Housing Choice Voucher Programs, and various grant programs. Reports to the CFO on all strategic and tactical matters related to budget management, cost-benefit analysis, forecasting needs and securing of new funding. Supervises all staff in the Finance Department. Adheres to all required financial compliance and auditing regulations pertaining to governance, GASB, and GAAP.

## **Years of Experience:**

Five or more years in a professional accounting or finance position preferably in a governmental environment.

#### **Education:**

Four-year degree with major coursework in accounting and/or finance.

### Responsibilities:

- 1. Provides oversight of the activities of the Finance Department including accounts payable, accounts receivable, banking, payroll, financial reporting, general ledger administration, grant financial reporting, banking transactions, procurement, and general accounting practices.
- 2. Prepares quarterly and annual financial reports and work papers preparation and organization including uploading of all client-prepared files to auditors shared file.
- 3. Secures and administers all organization-wide insurance needs including property, casualty, professional liability, flood, crime, and any other business insurance needs that might develop.
- 4. Administers various accounting and finance functions over affiliated organizations.
- 5. Assures tax reporting compliance including 941 filings, quarterly re-employment reporting, IRS TIN matching preparation in ACL and submission, W-2 and 1099 reporting.
- 6. Establishes and maintains systems and controls that verify the integrity of all financial systems, financial reporting, financial information systems, processes and data.
- 7. Provides HUD reporting support and certifications as needed.
- 8. Maintains current information on updates or changes to GAAP, GASB, Internal Audit guidance, HUD, GAO, and financial governance.

- Knowledge of budgeting and financial analysis in a small to mid-sized organization.
- Knowledge and experience in accounting or finance including compliance, reporting, governance, auditing, and document preparations.
- Knowledge and experience procuring and managing various business insurances, including property and casualty, helpful.
